1. The Gaindakot Municipality, Office of Municipal Executive has allocated funds towards the cost of project " **SUPPLY , DELIVERY OF MATERIALS AND H.T./ L.T. LINE EXTENTION WORKS IN VARIOUS PLACES OF GAIDAKOT MUNICIPALITY** " with estimated amount NRs. **81,44,638.33 (Without VAT)** and intends to apply part of the funds to cover eligible payments under the Contract for **SUPPLY , DELIVERY OF MATERIALS AND H.T./ L.T. LINE EXTENTION WORKS IN VARIOUS PLACES OF GAIDAKOT MUNICIPALITY**. Bidding is open to all eligible Nepalese Bidders.
2. Gaindakot Municipality, Office of Municipal Executive invites **Single Stage Single Envelope Electronic Bids** from eligible bidders for the **SUPPLY , DELIVERY OF MATERIALS AND H.T./ L.T. LINE EXTENTION WORKS IN VARIOUS PLACES OF GAIDAKOT MUNICIPALITY** under National Competitive Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best **3 years** within the last 10 years: **Nrs. 1,35,00,000.00 (Without VAT)**.
Minimum Work experience of similar size and nature: **One (1) Project** with a Value of **NRs. 70,00,000.00 (Without VAT)**.

4. Bidder shall download the bidding documents for e-submission from PPMO's Web Site **www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the cost **Nrs. 3000.00** as a non refundable fee of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Electronic bids must be submitted to the office through PPMO website **www.bolpatra.gov.np**. on or before **12.00** on **2075/03/14(28th June, 2018)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2075/03/14(28th June, 2018) , 14.00** at the office of Gaindakot Municipality , Office of Municipal Executive , Gaindakot -5, Nawalparasi, Province No. 4, Nepal. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of **Nrs. 2,30,000.00**, which shall be valid for **30 days** beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Each bidder shall bid only one bid, either individually or as a partner in a J/V. To facilitate contract administration, the number of partners in J/V is limited to three.
10. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
11. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
12. All other terms & conditions will be as per prevailing procurement act & regulations of government of Nepal.
